PAY ADVICE/CHECK EXPLANATION

1. Employee Earnings
 - a. This section shows all earnings for the specified pay period
 - b. The Days/Hrs. column reflects the number of hours for the earnings type
 - c. The Current Earnings column reflects the amount for each earnings in the pay period
 - d. The YTD Earnings column reflects your total year to date earnings for each earning type

2. Employee Deductions
 - a. This section shows all mandatory and voluntary deductions for the specified pay period.
 - b. The current deductions column reflects the amount of the deduction for the pay period
 - c. The YTD deduction column reflects the total year to date deduction amount for each deduction type
 - d. The Emplr and Empr YTD Columns reflect the amount paid by the County for the specified pay period and the year to date amount, respectively.
 - I. These amounts are not part of your net pay
 - II. These amounts are information only

3. Direct Deposit
 - a. If your pay is directly deposited in your bank account it will reflect here the amount for the specified pay period
4. NOTES
 - a. Important information, notices, and/or reminders regarding the pay check are displayed here.
5. LEAVE ACCRUALS
 - a. This section shows all accruals earned, used and balance for the specified pay period and the year to date earned and used amounts.
6. WITHHOLDING ALLOWANCES
 - a. This section reflects your Employee Withholding Allowance Certificate (W-4) selections.
7. ADVICE/ CHECK TOTAL
 - a. This section shows your total gross pay, taxable pay, deductions, and net pay for the pay period selected along with year to date balances for each.
 - b. Gross pay is the total amounts from section 1 for the pay period
 - c. Taxable pay is the difference between total amount from your gross pay and pre tax deductions
 - d. Deductions is the total amount from section 2 for the pay period
 - e. Net pay is the difference between gross pay and deductions.
