


**STANDING ORDER IN CIVIL MATTERS \*\***




Pursuant to the Texas Supreme Court order mandating electronic filing of civil matters effective January 1, 2014, the below listed courts enter this standing order:


1. A party requesting a written order on any matter shall provide directly to the Court a hard copy of the pleading supporting that request and a proposed order in compliance with Local Rule 3.04.
2. Parties shall provide a courtesy hard copy to the Court of motions, responses, and pertinent supporting documents, no later than 7 working days before hearing.
3. Parties shall prepare an electronic copy of admitted trial exhibits which are to be provided to the court reporter for preparation of the reporter's record.
4. Parties shall provide a hard copy of the proposed jury charge including any special issues or requested special instructions that are reasonably anticipated.


