PRE-HEARING MEETING AND OTHER PROCEDURES

It shall be the policy of the El Paso County Civil Service Commission to encourage the timely pre-hearing settlement_resolution of grievances. In keeping with this policy, all parties shall adhere to the following procedures:

Upon the filing of a grievance, Human Resources personnel shall advise the grievant of the existence of these Civil Service rules and provide a hyperlink to these rules on a paper form, as approved by the Human Resources Director. The grievant should acknowledge receipt by signing the form.

- (b) No fewer than 10 days nor more than 17 days from the filing of a grievance, the COUNTY ATTORNEY shall contact the grievant, or his or her attorney, if represented, and confirm that the grievant (or attorney) has obtained a copy of these rules and regulations;
- The Parties may agree to arrange an Alternative Resolution Meeting (ARM). The purpose of an ARM meeting is to determine if a mutually acceptable resolution to the grievance can be achieved prior to the hearing. A member of County Human Resources staff, as assigned by the Director of Human Resources, shall be present at any ARM to facilitate communication. County Human Resources staff may also assist the grievant with the ARM process if the grievant is not represented. However, Human Resources staff may not advocate on behalf of the grievant. In accordance with Texas law, discussions at an ARM are confidential and may not be recorded or otherwise entered into evidence at a grievance hearing or any other matter (see Texas Rule of Evidence 408).
- (d) Parties may request a continuance in order to facilitate alternative resolution in accordance with rule 7.26.
