Include any adjustments since last year's certification; exclude Tax Code Section 25.25(d) one-third over-appraisal corrections from these adjustments. 6.	<b>2018 taxable value, adjusted for court-ordered reductions.</b> Add Line 3 and Line 5C.	\$	116,655,000
7.	<b>2018 taxable value of property in territory the unit deannexed after Jan. 1, 2018.</b> Enter the 2018 value of property in deannexed territory.	\$	0
8.	<b>2018 taxable value lost because property first qualified for an exemption in 2019.</b> Note that lowering the amount or percentage of an existing exemption does not create a new exemption or reduce taxable value. If the taxing unit increased an original exemption, use the difference between the original exempted amount and the increased exempted amount. Do not include value lost due to freeport or goods-in-transit exemptions. 10.	<b>Total adjustments for lost value.</b> Add Lines 7, 8C and 9C.	\$ 9,798
11.	<b>2018 adjusted taxable value.</b> Subtract Line 10 from Line 6.	\$ 116,645,202
12.	<b>Adjusted 2018 taxes.</b> Multiply Line 4 by Line 11 and divide by \$100.	\$ 877,690.99
13.	<b>Taxes refunded for years preceding tax year 2018.</b> Enter the amount of taxes refunded by the taxing unit for tax years preceding tax year 2018. Types of refunds include court decisions, Tax Code Section 25.25(b) and (c) corrections and Tax Code Section 31.11 payment errors. Do not include refunds for tax year 2018. This line applies only to tax years preceding tax year 2018.	\$
14.	<b>Taxes in tax increment financing (TIF) for tax year 2018.</b> Enter the amount of taxes paid into the tax increment fund for a reinvestment zone as agreed by the taxing unit. If the taxing unit has no 2019 captured appraised value in Line 16D, enter "0."	\$
15.	<b>Adjusted 2018 taxes with refunds and TIF adjustment.</b> Add Lines 12 and 13, subtract Line 14.	\$
16.	<p><b>Total 2019 taxable value on the 2019 certified appraisal roll today.</b> This value includes only certified values and includes the total taxable value of homesteads with tax ceilings (will deduct in Line 18). These homesteads include homeowners age 65 or older or disabled.</p> <p>A. <b>Certified values:</b></p> <p style="text-align: right;">\$ 113,956,666</p> <p>B. <b>Counties:</b> Include railroad rolling stock values certified by the Comptroller's office:</p> <p style="text-align: right;">+ \$ _____ 0</p> <p>C. <b>Pollution control and energy storage system exemption:</b> Deduct the value of property exempted for the current tax year for the first time as pollution control or energy storage system property:</p> <p style="text-align: right;">-\$ _____ 0</p> <p>D. <b>Tax increment financing:</b> Deduct the 2019 captured appraised value of property taxable by a taxing unit in a tax increment financing zone for which the 2019 taxes will be deposited into the tax increment fund. Do not include any new property value that will be included in Line 21 below.</p> <p style="text-align: right;">-\$ _____ 0</p> <p>E. <b>Total 2019 value.</b> Add A and B, then subtract C and D.</p>	\$ 113,956,666

17.	<p><b>Total value of properties under protest or not included on certified appraisal roll.</b></p> <p><b>A. 2019 taxable value of properties under protest.</b> The chief appraiser certifies a list of properties still under ARB protest. The list shows the appraisal district's value and the taxpayer's claimed value, if any or an estimate of the value if the taxpayer wins. For each of the properties under protest, use the lowest of these values. Enter the total value. <span style="float: right;">\$ <u>          2,572,276</u></span></p> <p><b>B. 2019 value of properties not under protest or included on certified appraisal roll.</b> The chief appraiser gives taxing units a list of those taxable properties that the chief appraiser knows about, but are not included in the appraisal roll certification. These properties also are not on the list of properties that are still under protest. On this list of properties, the chief appraiser includes the market value, appraised value and exemptions for the preceding year and a reasonable estimate of the market value, appraised value and exemptions for the current year. These include the homesteads of homeowners age 65 or older or disabled. Other taxing units enter 0. 19.	<p><b>2019 total taxable value.</b> Add Lines 16E and 17C. Subtract Line 18. <span style="float: right;">\$ <u>          116,528,942</u></span></p>	
20.	<p><b>Total 2019 taxable value of properties in territory annexed after Jan. 1, 2018.</b> Include both real and personal property. Enter the 2019 value of property in territory annexed. <span style="float: right;">\$ <u>                          0</u></span></p>	
21.	<p><b>Total 2019 taxable value of new improvements and new personal property located in new improvements.</b> New means the item was not on the appraisal roll in 2018. An improvement is a building, structure, fixture or fence erected on or affixed to land. New additions to existing improvements may be included if the appraised value can be determined. New personal property in a new improvement must have been brought into the unit after January 1, 2018, and be located in a new improvement. 24.	<p><b>2019 effective tax rate.</b> Divide Line 15 by Line 23 and multiply by \$100. <span style="float: right;">\$ <u>                  /\$100</u></span></p>	
25.	<p><b>COUNTIES ONLY.</b> Add together the effective tax rates for each type of tax the county levies. The total is the 2019 county effective tax rate. <span style="float: right;">\$ <u>                  /\$100</u></span></p>
